1. Types of roles and access

There are a few different types of roles on Environment Online that will allow you and/or your organisation to be able to manage projects, applications, and user access. Please refer to the table below.

2. Registering for an Environment Online account:

Depending on the type of access you need (see 'Types of roles and access on Environment Online'), there are multiple methods for registering for an account.

You do not need to create an account to access publicly available information such as projects, proposals, applications, stages of assessment, locations, reports, and recommendations and/ or to submit an enquiry.

	Using your email and password
For individuals wanting to access limited services*	Register for an account using a valid email address, creating a password and following the Multi-factor Authentication steps with either a mobile phone number or using your preferred authenticator application.
	You will only be able to access limited services* with this type of account. For more information, please use the <u>representing myself guide</u> .
If you are representing another person or organisation	Register for an account using a valid email address, creating a password, and following the Multi-factor Authentication steps with either a mobile phone number or using your preferred authenticator application.
	If representing an organisation, the representative must already have an account using the Microsoft Work Account or Digital Identity methods. For more information, please use the representing an entity guide. If you are unsure, check with the organisation directly or contact EO support.
	The type of access you have will depend on the permissions the organisation or person you are representing has given you.
